Course Overview:

This course analyzes the economics of public health and health care in the United States with particular attention to the role of government. Topics covered include trends in health care costs and public health, social determinants of health; the demand for health and health care; the market for health insurance; the supply-side of the health care industry; disparities in health outcomes and access to care; and evaluations of recent state and federal reforms.

Prerequisites: Econ 4351 or Econ 3251, and Stat 2500 (or permission)

Readings:

Text Book: Phelps, 2013. Health Economics. 5th Edition. Boston, MA: Pearson.

Additional required readings will be distributed in class or on the course website. In addition, class lectures will often refer to current events and policy debates; for this reason, students are strongly encouraged to read a national newspaper.

Course materials including handouts, supplemental readings, homework assignments and any important course announcements will be posted on the Canvas site.

Expectations and Decorum:

Students are expected to attend all lectures and complete all assignments. In the case of unavoidable absence, be sure to obtain lecture notes from classmates. Also, please refrain from creating negative externalities. For example, mute electronic devices and avoid entering or exiting during class time, except as required by the norms of polite society.

Grading:

Course grades are based on the average score of three in-class exams. In addition, students may complete two short reaction paper for up to 3 points extra credit (per paper). Students enrolled in Econ 7357 must also complete a well-written literature review or research note for graduate credit.

Exams:

Exams are taken in class and are closed book. Exams usually include several sections in order of ascending difficulty (e.g., definitions\true-false, multiple choice, short answer problems and short essay problems). There are no make-up exams; absence from an exam will be excused only in the case of a medical or personal emergency (see below).

Reaction Papers:

A reaction paper is 3-4 page essay that applies, critiques or extends some lesson from class discussion or readings. For example, a reaction paper may update or reanalyze data presented in class, critically review a recent study, or analyze a news report on events directly related to some aspect of health economics. Reaction papers are scored based on: 1) the quality of the writing, 2) the quality of the analysis, and 3) the originality, creativity and presentation.

Reaction papers should be double-spaced and single-sided with 12 point font and oneinch margins all around. Your writing must be free of all spelling and grammatical errors, as well as clear, concise and correct. Use social science conventions for in-text references, footnotes and bibliography (e.g., see sections D-G, J & L in the *American Economics Review* style guide, available at:

https://www.aeaweb.org/journals/aer/submissions/accepted-articles/styleguide).

Emergency Related Issues:
