COURSE DESCRIPTION

This course rigorously develops the theory of rational behavior in the context of consumption, production, and pricing strategies and decisions on the part of households and firms. Partial equilibria are derived from the rational behavior of market participants in a variety of market settings, i.e., competition, monopoly, monopsony, oligopoly and monopolistic competition. Brief introductions to general equilibrium in competitive markets and welfare economics are provided.

This is a problem solving class, much like a math class. Thus, the only way to learn the material is to work problems as the course progresses.

ATTENDANCE AND PARTICIPATION POLICY

You are expected to **attend all lectures**. Your attendance and participation will help you learn the material more efficiently and better, and **may** also help you obtain a higher grade at the end of this semester (in borderline grade cases). **In case of unavoidable absence**, note that you are still responsible for all material covered in the missed lecture and any shortcomings that may result from missing class (e.g., missing extra credit opportunities).

Lectures will include **NOT ONLY** material from the text, **BUT ALSO** other related concepts and examples, and current policy discussions regarding the U.S. economy in the media. You are responsible for the material covered in the course. **IN CASE OF UNAVOIDABLE ABSENCE**, obtain lecture notes from classmates. The instructor’s or TAs’ lecture notes will not be available to you.

WORKSHEETS

The worksheet will be posted regularly according to the lecture discussion of a topic. It contains additional problems that you should work on but it is not collected. Please check the course Canvas.

GRADING

HOMEWORK (HW) AND IN-CLASS (IC) QUIZZES (A TOTAL OF 80 POINTS)

Two HWs and two IC quiz scores will count toward your semester grade. There will be three HWs and three IC quizzes (worth 20-points each) administered so that you may drop your lowest HW and your lowest IC_quiz scores, or be excused from one of each during the semester.

You may **submit HW** to your TA **in advance** in case of a scheduled absence on the due date. Otherwise, HW will be collected in class **between 12:20pm and 12:30pm** on the due date. Any submission after **12:30pm** on the due date is considered to be late. **No late HW** will be graded, even if it is only one minute late. Note that only your two highest scored HWs will count toward your grade.

NOTE: You are encouraged to cooperate with your classmates on **HW** (work in groups, discuss the solutions). However, you must submit your own handwritten copy with your name on it.

NOTE: **IC Quizzes** will **only** be administered during **scheduled times**. Quiz questions will be a combination of multiple-choice and short problem solving, and will typically be similar to questions in pop quizzes, HW and/or worksheets.

POP QUIZZES (POP_Q: A TOTAL OF 20 POINTS)

There will be **5 unannounced Pop Quizzes** (worth 5 points each). Only the top four scores will count towards your semester grade. Any missed quizzes will be scored as zero even if you have an excused absence.

NOTE: Missed or late HW, unexcused (i.e., no documentation) missed quizzes and exams will be scored as zeros.

NOTE: The worksheets, HW and quizzes will reinforce your learning of class material (lectures, text and Wall Street Journal readings). Hence, they will be excellent practice for preparing for the main exams.
