COURSE OVERVIEW

The objective is to leave the course with an advanced understanding of macroeconomics. In the course you will learn about macroeconomic data, monetary policy, fiscal policy, economic growth and business cycles. The course will consider both the United States, as well as events in the rest of the world. Throughout the course we will link the theories in the book to current events.

COURSE EXPECTATIONS

This course is primarily a lecture course. I will alert you in advance of required reading from the textbook chapters.

The way to succeed in this class is to read the text before class, attend lecture, bring copies of the slides (posted on canvas) to class, take careful notes. The posted notes are far from complete, they largely contain definitions and equations. You should also come talk to me during office hours to be sure you understand the material.

I expect you to attend all classes. You will not learn the material if you do not come to class and pay attention. That said. I will not take attendance.
