Course Catalog Description:

An introduction to the study of how macroeconomic forces and public policy affect the welfare of a nation. Topics include understanding the business cycle, economic growth, inflation, interest rates, and unemployment, as well as the effects of fiscal and monetary policy. Not open to students who have completed ECONOM 1000 or ECONOM 1051. Graded on A-F basis only.

Course Objectives

It is my hope that you will learn the theory of macroeconomics and be able to apply this theory to current events and concerns. With our toolkit, we will cover a mix of traditional macroeconomic questions, including:

- What drives economic growth?
- What causes business cycle fluctuations?
- What is the impact of fiscal and monetary policy?

We will also discuss more timely questions, including asset bubbles and crises, sovereign default, drivers and consequences of inequality, trade, and labor market issues.

Building this toolkit takes both effort and time. I will provide the resources and instruction for you, but there is no substitute for hands on trial of these methods. Economics is learned best by doing it. As such, I will also provide an environment for you to work with the theories in order to deepen your technical skills and intuition.

At the end of the course, I hope that

- (1) You are able to engage in informed discussions about macroeconomics and make informed judgements about causes, implications, and policy responses to various macroeconomic phenomena
- (2) You further develop your technical skills and intuition used in macroeconomic analysis
- (3) You discover areas of study that interest you and provide a basis for future paths

Course Policies and Procedures

In-Class Participation: You are expected to attend all lectures.

Participation points: Work assigned, completed, and handed in during lecture, including REEF polls, REEF check-ins, worksheets, and paper sign-in sheets. No makeup work for "in lecture" participation is accepted (work that is due by the end of the lecture section in which it is assigned). If you have a valid university function, medical documentation, or extraordinary personal event, you will be excused from the participation work for the relevant lecture times. Some participation activities may be assigned during lecture but due later in the week to Canvas. You do not need to attend the lecture to hand in these participation assignments.

Concept Check Quizzes: Each book chapter has a "Concept Check Quiz" posted on Canvas. This quiz highlights the key concepts from that section and is designed for you to check your understanding. You have unlimited tries at this quiz and only the highest score is entered into the gradebook.

Homework: The class includes 6 homework assignments. Your top 5 scores will count towards your final course grade. This means that you will drop your lowest homework grade (whether it is a low score or an assignment you did not submit). **No late homeworks will be accepted.** Homeworks are available a week before they are due, no exemptions will be granted for weekly homework.

Homework Due Dates: Homework is on Sunday to Canvas by 11:59pm. Exact due dates are posted on Canvas. Your upload must be timestamped prior to 11:59pm.

Homework Submissions: You must submit your homework via a PDF file upload to Canvas. See Canvas for instructions on converting your work to a PDF.

Make-up Classes: Rarely (due to illness, weather event, or other emergency) class may be cancelled. If class is cancelled, a note will be distributed using the "Announcements" feature on Canvas. Cancelled classes will be accompanied by a current event analysis or video. These assignments will count either towards your homework or participation grade. If the assignment counts towards homework, you cannot drop that assignment at the end of the semester.

Exams: This course consists of three in-class exams during the semester and one final exam given at the predetermined time assigned by the University.

Exam Dates and Times: Exams during the semester are scheduled for the following class periods:

These exams are non-cumulative and cover the information from lecture and the assigned readings.

Make-Up Exams: No makeup exams will be offered for this course. If you miss a scheduled exam for medical or extraordinary personal reasons, the exam will be your dropped score. In the unlikely event you miss more than one exam, you will be exempt from one missed exam and drop the other missed exam. This means that your other two exams will count for 22.5% of your grade (rather than 15%). In either circumstance, if you miss an exam you must take the final. You must notify Prof. Whitworth immediately upon learning that you will miss the exam, but no later than the Wednesday following the exam (2/19, 4/1, and 5/6). If you are unable to submit all three in-class exams, your final will count for the full 45% of your grade.

Final Exam: The final exam for this course is required and given at the University Assigned Final time (Spring 2020 final times:

Exam Materials: For in-class exam, you may prepare a single sided 8.5"x11" (standard letter size) "cheat sheet" that include any information you deem helpful on the exam. Make a copy or take a picture of the cheat sheet, they will be collected at the exam and not returned. For the final, you are allowed to use a double sided 8.5"x11" cheat sheet. You may also opt to use 2 single-sided sheets (the single sided property of these sheets will be verified at the exam)
