COURSE DESCRIPTION:

Health and health care are one of the central aspects of human life and well-being throughout the lifecycle. Health economics is a growing field within economics that explores the determination of prices, quality, and quantities, and allocation of scarce resources devoted to health and health care.

This course introduces the key concepts of health economics. The course will cover various features of health care markets and their implications such as uneven and unpredictable incidence of illness; externalities; asymmetric information between consumers, insurers, and health care providers; the demand and consequences of health insurance; restricted market entry; labor market monopsony. We will study how economic behavior factors into health and health care decisions and discuss how to apply economic thinking to understand issues in health care and policy.

Prerequisite(s): ECONOM 3251 or ECONOM 4351 and (STAT 2200 or STAT 2500) or equivalent.

LEARNING OBJECTIVES:

After completing the course, you will be able to:

- Identify and explain the key concepts of health economics.
- Explain how economic behavior factors into health and health care decisions.
- Apply economics to understand issues in health care and policy.

Additional course materials including slides, supplemental readings, exercises, homework assignments, and course announcements will be shared in class. These materials are intended for class use only and should not be distributed outside the course.

ASSIGNMENTS AND GRADING:

Grading: This course will use a plus/minus grading system, as per the university's grading policy.

For 4357 students, your grades will be based on Homework (10%, the lowest homework score will be dropped), Midterm 1 (35%), Midterm 2 (non-comprehensive) (35%), and a Group Project (an oral presentation + a final paper of 5 pages) (20%).

For 7357 students, your grades will be based on Homework (10%, the lowest homework score will be dropped), Midterm 1 (35%), Midterm 2 (non-comprehensive) (35 %), and a Group Project (an oral presentation + a final paper of 15 pages) (20%).

Assignments: Seven Homework Assignments (that will be returned using Canvas as a file upload) will be given throughout the semester. *All homework assignments are due at 6pm CT on the due date*. Active participation in class is required to receive full credit for homework.

The objective of homework is to support your learning, so I encourage you to begin assignments early. Homework and class materials will serve as important preparation for exams. Unless otherwise specified, homework should be completed independently. If group work is permitted, I will clearly note this, and you will be asked to list your group members.

Group Project: Students are required to complete a group project consisting of a written paper and an oral presentation. The oral presentations will take place in class during the latter part of the course, and the final paper is due prior to the presentation.

ACADEMIC INTEGRITY
