Course description:

This course provides students an understanding of how individual economic agents, such as households and firms, make decisions and interact in markets. Students will also learn how markets allocate inputs among producers and output among consumers and how government policies address market failures.

Required Textbook:

- Cowen and Tabarrok, Modern Principles: Microeconomics 5/E (Achieve AutoAccess Automatic for all enrolled students.)
- The textbook is highly recommended since lectures will be based mostly on the material in the textbook. Besides, the textbook is a valuable resource for supplemental readings and additional problems which would improve your exam performance and help you get the most out of this class.
- I will assign readings from the textbook periodically.

Grading

Exams: There will be 3 midterms and a final. All exams will take place in person.

- <u>Midterm exams</u> will only cover the material we have studied since the previous exam, but many concepts build on each other throughout the semester. The <u>final exam</u> is cumulative, however the recent chapters will be the main focus.
 - Midterm exam 1: Tuesday 9/14
 - Midterm exam 2: Tuesday 10/12
 - Midterm exam 3: Thursday 11/18
 - Final: TBD
- Exams are closed book and may include three sections: multiple choice, short answers, and short essays. Students may be required to show a current student ID with a photo at each exam. For each exam, including the final, you can use a non-graphing calculator.

• If you are unable to sit for an exam due to an excused absence, you must notify me as soon as possible (before exam day). An alternative closed book exam will be administered within one week of the exam date. Excused absences include illness of the student, illness of an immediate family member under the student's care, religious observance, representation of the University of Missouri in an official capacity, and some other unforeseen circumstances.

In-class quizzes: There will be <u>6</u> unannounced in-class quizzes at the beginning of a class period. The main purpose of these quizzes is to ensure that you have understood the material from the previous lecture. If you spend an hour studying your notes from the previous class, you should not have trouble with quiz questions. The quizzes will also give you an incentive to regularly attend class. Missed quizzes will be scored as zeroes. However, I will drop your lowest quiz grade, which can be used to cover a missed quiz.

Homework: Homework has to be submitted online using Canvas.

- Submissions can be scanned versions of your written homework or typed documents. You are responsible for letting me know before the due date if you have any problems submitting homework.
- Homework will be your best study guide along with the textbook, notes, and quizzes.
- I will only grade homework for completion so as long as you have attempted every question you should get full credit for homework. However, I am going to thoroughly examine your effort and make sure you have completed your homework.
- You are welcome to visit my office hours to get help with problem sets, though it's very important that you attempt the problems yourself first. I also highly recommend working with your peers.
- No late homework will be accepted. However, I will drop your lowest homework assignment grade, which can be used to cover a missed assignment.

Assignment Weights

Your course grade will be based on three midterm exams, homework, quizzes, and a comprehensive final exam.

Responsibilities and Expectations

Course Expectation: <u>Students are recommended to take detailed lecture notes</u> and also expected to complete all reading assignments on time. This class will be interactive where students are expected to participate and work with their peers. I also expect students to spend 2-3 hours outside of class for every hour in class. Besides reviewing notes, it is beneficial to meet with other students and discuss class material. You are encouraged to ask questions

anytime. I am here to help you so please feel free to ask questions related to class material before class, during class, after class or during office hours.

Absence Policy: Students registered for this section are expected and encouraged to attend class in-person. Exam questions will be based on the textbook, lecture notes, quizzes, and homework so attending classes is only going to help you succeed in this class. We all are going through a tough year so with that in mind, each lecture will be recorded for asynchronous viewing via Panopto. When you are absent, it is your responsibility to watch lecture videos, take notes, and ask for lecture notes from your peers if needed. Of course you are welcome to drop by my office hours when you need clarification or have questions regarding class materials.

Late Policy: Quizzes will be given at the beginning of the class, so if you are late, please keep in mind that you will have less time to complete your quiz. It is also a sign of respect to me and your classmates to be on time for class.

Electronic Devices Policy: Mute all of your electronic devices during lectures. Laptops will not be needed for notetaking because this course is heavy on figures and mathematical formulas. If you wish to use electronic devices to take notes, please come talk to me. Absolutely no electronic devices during exams other than a non-graphing calculator.

MU Policies and Expectations

Decreasing the Risk of COVID-19 in Classrooms and Labs:

FERPA:

The Family Educational Rights and Privacy Act (FERPA) of 1974 is a federal law designed to protect the privacy of educational records; to establish the rights of students to inspect and review their education records; and to provide guidelines for the correction of inaccurate and misleading data through informal and formal hearings. The law applies to any individual who is or has been in attendance at an institution and regarding whom the institution maintains educational records. Once students have matriculated to the University of Missouri, i.e. enrolled in course work, FERPA rights transfer to the student, regardless of the student's age.

Students can enable certain individuals to have access to their education records by signing a <u>FERPA waiver</u>. The consent must specify records to be disclosed, state the purpose of the disclosure and identify the party or class of parties to whom the disclosure must be made.

Academic Inquiry, Course Discussion and Privacy:

When students record something that happens in a course (a lecture, class discussions, meetings, etc.) it has an impact on the rights of the people captured in that recording. For example, the instructor and the University

may have rights to the intellectual property contained in that recording. At the same time, another student who may have been recorded has the right to privacy. In order to protect these rights, MU employs a policy (called <u>"Executive Order No. 38"</u>) to govern both situations you may encounter while taking a course – when an instructor allows recordings and when they do not.

• In this class, students may make audio or video recordings of course activity unless specifically prohibited by the faculty member. However, the redistribution of audio or video recordings of statements or comments from the course to individuals who are not students in the course is prohibited without the express permission of the faculty member and of any students who are recorded.
